

What is Pupil Premium?

Pupil Premium is additional funding given to schools in order to try and address the underlying inequalities between children eligible for free school meals (FSM) and their peers. Funding must be used to tackle disadvantage, reaching the pupils who need it most.

Introduced in 2011, Pupil Premium is allocated for pupils who have been registered for FSM at any time in the last 6 years (this is known as 'Ever6 FSM'). Pupil Premium funding is also given for children who are looked after, or have ever been looked after and children of service personnel.

Context of the school.

Hollingbourne is smaller than the average sized primary school. The school is half form entry. Children in the early years are taught in one full-time Reception class. There are three other mixed-age classes. The majority of children are from a white British background. The proportion of children eligible for FSM is much lower than that found in most schools. The proportion of children who have special needs or disability is also lower than the national average. The school meets the government's floor standards, which sets the minimum expectations for pupils' attainment and progress in English and mathematics.

Barriers to future attainment (for pupils eligible for Pupil Premium)

In school barriers (issues to be addressed in school)

A	Pupil Premium children are less likely to reach age related expectations in maths.
B	Pupil's eligible for Pupil Premium who are emotionally and socially vulnerable are less likely to thrive.
C	Pupil premium children who are also SEN have existing barriers to learning, impacting further on rates of progress and therefore attainment

External barriers (which require action outside of school)

A	Pupils eligible for PP are more likely to experience interruptions in their emotional and social lives
B	Pupils eligible for the PP are less likely to experience enrichment opportunities
C	40% of PP children have attendance lower than 96%

TA/ teacher support (to provide additional support in class)	£8360	To further boost progress in class particularly in maths
TA support (small group work outside of classroom)	£4,000	To close gaps in attainment and progress where needed by addressing misconceptions etc
